Co-drivers, a husband and wife team, stopped at the Knox Fuel Stop, East I-30, Royse, Texas and went into the restaurant; the rig was taken about 10 minutes later at approximately 5:35 p.m. on Saturday, Feb. 16.

In addition to locking the tractor's doors, the driver had what he described as a "Quad Lock" that when locked should have caused the tractor's airbrakes to lock up within a few minutes of the theft. The driver was adamant that the "Quad Lock" was set.

Drivers picked up the load in Knoxville, TN on Friday, Feb. 15 and had driven straight through to Texas. This stop was the first one where both drivers were out of the tractor.

The value of the load is still being worked on, though the first estimate is \$6 million.
